Laboratory note: The estimated concentration of the unknown peak in the sample is 0.40% | Currently PharmLabs laboratory can not confirm an unidentified peak in your chromatogram due to interference (only with highly concentrated D8 products) from which we believe to be either (+)-THC or (-)-THC. At this time there are no reference standards available for (+)-THC. (+)-THC is a different compound from the main (-)-THC cannabinoid and, therefore, these two compounds may have different efficacies. Using the most advanced instruments and techniques available, the separation of (+)-THC and (-)-THC is problematic for the scientific community as a whole. PharmLabs believes the unidentified peak to be a combination of (+)-THC and (-)-THC with the majority, if not all, of the concentration being (+)-THC. Total d8-THC is estimated to be 3.80%.
